DCCCO Journeys towards ACCESS Branding

DCCCO Multipurpose Cooperative aspires to be an ACCESS-Branded Cooperative which will serve as a concrete manifestation in the realization of its new vision of becoming a "World-Class Cooperative, driven by Excellence and Caring Service that acts as a catalyst for enriching the quality of life of Filipinos". ACCESS which stands for "A1 Competitive Choice for Excellence in Service and Soundness" is a quality assurance that was formed by the members of the Association of Asian Confederation of Credit Unions (AACCU) which is being cascaded down to the primary cooperatives through the Philippine Federation of Credit Cooperatives (PFCCO) of which DCCCO has been affiliated with.

ACCESS Branding aims the following:

- 1. to measure the capabilities of the cooperatives to serve and provide the needs of its members, and its ability to progress and develop;
- 2. to improve the quality of life of service that DCCCO may provide its members;
- 3. to equip DCCCO with the tools needed to build the organization-wide quality assurance strategy; and
 - 4. to ensure the sustainability of DCCCO.

The accreditation process for ACCESS Branding is quite a challenging journey. The requirements for a cooperative to get ACCESS Certification is clearly more stringent. In its initial stage, DCCCO management and officers have embarked on the four-day mentoring and coaching workshop sessions in January 2016 with Mr. Ernan Palabyab of PFCCO as the resource person. Mr. Palabyab thoroughly explained the ACCESS Branding Manual as the guiding tool towards achieving an ACCESS-BRANDED COOPERATIVE. The ACCU developed the Balanced Scorecard architecture comprising 86 indicators on four aspects of operations which are member-owner, internal business processes, learning and growth and financial. These ACCESS indicators reflect the financial state or health of a cooperative. The participants are composed of the Board of Directors, Treasurer/Secretary, Audit Committee Officers, ETICommittee Vice-Chairperson, CEO, Managers; Head Office Division Heads organized themselves into four ACCESS Audit Teams, namely: 1) Member-Owner Perspective; 2) Internal Business Process Perspective; 3) Learning and Growth Perspective and 4) Financial Perspective. These Audit Teams went through a series of workshops, SWOT analysis and identified "lot parking items" relevant to their assigned perspective. The "lot parking items" are basically the different

areas in the coop operation that need attention in order to provide efficient and effective services to members. To culminate the activity the Chairperson of PFCCO National, Atty. Gloria G. Futalan and Atty. Vivian O. Maquiling led the signing of the Memorandum of Agreement (MOA) on the official enrollment of DCCCO to ACCESS Branding on January 14, 2016. Henceforth, the Audit Teams conducted series of meetings and workshops to follow-up the progress of the respective "lot parking items".

On April 28, 2016, the Association of Asian Confederation of Credit Unions through its Chief Executive Officer, Ms. Elenita V. San Roque, CPA, DE and the Philippine Federation of Credit Cooperatives National through its Chairperson, Atty. Gloria G. Futalan conferred to DCCCO, the Certificate of Enrollment to ACCESS Branding. The recognition was held at Bethel Guest House, Dumaguete City during the 2016 Educational Forum of PFCCO National.

DCCCO's commitment to live the cooperative philosophy, values and principles and comply to international standards set by ACCUU through ACCESS Branding is a legacy that DCCCO will offer to its members in celebrating its Golden Jubilee in 2018. As DCCCO SOARS (Sailing On toward Active and Responsive Service), we entrust everything to our God Almighty, the source of everything.

Editorial The need for DCCCO Chapter Assemblies

With eight (8) branches in Negros Oriental, Negros Occidental and Siquijor Provinces, over 80,000 members and 2.7 billion in assets, the country's Number Eight (8) Billionare Cooperative in 2014 and 2013 Most Outstanding Cooperative (large category) in the Philippines, DC-CCO Multipurpose Cooperative has really gone a long way from its humble beginnings of 49 members in 1968 and a measly fund of over a thousand pesos.

Considering its extensive reach and the increasing number of people who want to become members of this cooperative, creating efficient body to assist the cooperative's officials in implementing its policies and in carrying out its diversified and multi-faceted objectives has become exceedingly necessary. DCCCO calls these bodies "chapter assemblies."

To date, its 3rd Chapter Assemblies have been successfully held in Guihulngan City, Bayawan City, Siquijor, Bais City and in the City of Dumaguete. These gatherings have been conducted in preparation for the forthcoming 2017 Annual Representative Assembly slated in March next year.

Now that DCCCO has become the leading cooperative in the Visayas and in the Philippines garnering significant awards in various areas, holding these assemblies has grown to be an indispensable exercise. For one, these gatherings will provide the venue and the opportunity for the Board of Directors and the different cooperative committees to report their



progress. These assemblies likewise give member-owners the chance to raise questions regarding certain cooperative policies and implementations. In addition, these assemblies will offer cooperative stakeholders the opportunity to make recommendations to enhance DCCCO's operations and improve its services. With the opening of its three additional branches – Sibulan (2015), Kabankalan (2014), San Carlos City (2013) – holding these assemblies has become essentially pragmatic and valuable.

To assure smooth and convenient conduct in the selection of assembly representatives, DCCCO management has opted to modernize its processes, that is, from registration of members to the selection of assembly representatives, everything is electronically operated. Thus, aside from saving time during the process, the cooperative and its stakeholders are likewise assured that the selection will be honest and impartial since it will be the machines that will do the selection based on a given criteria.

CEO Participates in the Women's Mentorship Program



DCCCO Multipurpose Cooperative Chief Executive Officer (CEO), Flordeliz V. Bokingkito, is one of the 11 women co-operative leaders in Asia and Africa chosen by the Canadian Co-operative Association (CCA) to participate in the 2016 Women Mentorship Program held in Canada from May 30 to June 25. This Program is a global development initiative created by the CCA and supported by the Co-operative Development Foundation of Canada. It provides a unique professional development opportunity to female credit union managers of overseas financial co-operatives – many of which are in developing countries.

The 11 women were given classroom trainings on Strategic Planning, Human Resource Management, Gender and Development, Leadership, Products and Services, Marketing and Innovation and Change Management. The team of facilitators and mentors included Catherine Dangerfield, Betty Bauhuis, Njeri Kontulahti and other women co-operative leaders who shared their

success stories. Mr. Vito Scuderi, the Program Manager, Mr. Chima Okonkwa and other CCA staff facilitated all the preparations and made sure that the women leaders had a memorable and meaningful experience in Canada.

From June 10 to June 17, 10 different credit unions across Canada hosted the 11 women from six countries including: Kenya, Ghana, Malawi, Philippines, Nepal and Myanmar for the Program. Cypress Credit Union in Maple Creek, Saskatchewan hosted CEO Bokingkito. She had an enriching learning experience being mentored by Cypress Credit Union leaders: CEO Glen Goddard, Lending Manager Larry Carnegie and women managers who each shared insight of the daily operations of a Canadian credit union and how the Canadian co-operative financial sector works in local communities. One of the highlights of her experience with Cypress Credit Union was the process in the opening of new accounts; who happened to be a Filipino family.

DCCCO Integrated and Diversified Ecological Farm

The Promotion of environmentally sound and healthy farm products is very important with the growing demand of organically grown commodities by health-conscious consumers. We can seldom find organically grown products since organic practitioners are still few and production is limited. This is the reason why DCCCO developed an integrated and diversified demo farm showcasing ecological farming system. It is the best farming alternative which is in harmony with nature, protects the environment and promotes a state of health.

DCCCO started to develop a 1,795 square meter agricultural land in Magtuhao, Tayasan, Negros Oriental into an integrated and diversified ecological farm. It has several plots planted with different kinds of vegetables, herbs and spices which include alugbati, ampalaya, arugula, petchay, cucumbers, eggplants, kangkong, lemon grass, lettuce moringa, radish, sweet potato leaves, red spinach, sweet basil, squash, tomatoes, chili and bell pepper with some root crops like sweet potatoes and cassava. The caretaker, Mr. Florante Sanchez known as "Nong Ite" was trained by an agriculturist in the person of Ms. Merlissa Garcia, in tending the plants and preparation of Natural Fermented Solutions and Vermi cast as organic fertilizers. Ms. Garcia is the Training Officer and Organic Guarantee Officer Designate of Negros Island Sustainable Agriculture of Rural Development (NISARD).

Aside from tending the plants, Nong Ite, who is also a carpenter, built a nice bahay kubo beside the farm. DCCCO is starting to market some of the vegetables to one of its members, Mrs. Angie Olivares, who is a vendor of organic vegetables at the



"Paunay" at Provincial Nursery. For close monitoring and marketing, management of the farm will be transferred to Guihulngan Branch early this year. One of the members of the Education, Training and Information (ETI) Committee from the Branch, Mrs. Jean Munoz will assist in the supervision of the farm. She is a retired employee of the Agriculture Office in Guihulngan.

Since its development in June 2014, the demo farm is now starting to showcase organic farming technology and practices to help support the demand of health-conscious consumers and advocates healthy food needs. The implementation of the program is DCCCO's active participation in the government's promotion and propagation of organic agriculture in the province. This is in response to the core value of Social Responsibility.

Women Group Officers visit May's Organic Garden and Restaurant

The DCCCO Women Group Officers visited May's Organic Garden and Restaurant in Aning, Barangay Pahanocoy, Bacolod City on May 20-21, 2016. The officers include Cheryl Rosales, Mercedita Tuballa, Elisa Semillano, Esmeralda Rivera with DCCCO Staff Mona Liza Nemenzo and Dennis Ogue.

The purpose of the visit is to learn more about organic lifestyle, organic farming technologies, waste segregation and to

establish rapport among staff and officers.

May's Organic Garden and Restaurant is an eco-park, a resort, a garden, a hotel and a restaurant rolled into one and established for a cause. Its accommodation is at par with those of the best hotels but it has the advantage of having the ambiance of a home. The restaurant serves fresh organic fruits and vegetables from its own garden. Drinks are mostly malunggay with pineapple juice and cucumber with tarragon.

It also has vermiculture production, organic livestock, organic rice, herbs and spices aside from the PURO Organic processing plant that produces organic coffee, rice, coco sugar, yogurt, cheese, piaya and calamansi juice. RU Botanicals has an oil distiller in the park and it produces lemon grass and citronella essential oils. These products are also sold at May's Organic Garden to help farmers earn more.

RU Foundry and Machine Shop are producers of different kinds of shredders and other equipment. In addition to these, the place has well-manicured landscaped areas which serve as venues for small events and grand occasions as well. Amenities like swimming pool and jacuzzi are also available for

guests.

This place is not only for business but also for making worthwhile and ecological projects a possibility.

DCCCO holds 3rd Annual Representative Assembly

DCCCO held its 2016 Annual Representative Assembly (ARA) at the Lamberto Macias Sports and Cultural Center, Capitol Area, Dumaguete City on March 13, 2016 with the theme: DCCCO S O A R S which stands for Sailing On toward Active and Responsive Service.

The assembly formally opened at 9:00 o'clock in the morning with a thanksgiving mass officiated by the Most Rev. Bishop Julito B. Cortes, D.D. of the Diocese of Dumaguete. Bishop Cortes named the annual gathering of DCCCO member-representatives as "panagtigum para pasalamat sa grasya nga nadawat" (a thanksgiving gathering for all the blessings received) and "panagtigum sa kalipay ug sa paglaum" (a gathering of joy and hope).

In his homily challenged everyone by asking: "How can DCCCO soar, and indeed, sail on toward active and responsive service?" He reminded the officers and the management to revisit the principles why DCCCO was conceived and why it was born.

After the mass, the Board Chairperson, William E. Ablong, thanked the bishop for celebrating the mass and accepted the bishop's challenge for DCCCO to exercise and perform corporal and spiritual works of mercy.

The Annual Representative Assembly was organized in







accordance with DCCCO's Articles of Cooperation and By-laws. Section 14 of the By-laws provides that "the Cooperative shall hold its annual regular Representative Assembly meeting every second Sunday of March at the principal office of the Cooperative or at any place within its area of operation and at such time the Board of Directors may designate."

Some 3,884 member representatives representing 76.79% of the total number of ARA representatives, which was 5,058, attended the assembly. The needed number of representatives to constitute a quorum in the ARA was only 1,264 members, representing at least twenty-five percent (25%) of the total number of member-representatives (5,058) entitled to vote.

The Assembly elected four members of the Board and two members of the Audit Committee. Those who were elected were William E. Ablong (1,994 votes), Marina C. Mendoza (1,521), Vivian O. Maquiling (1,389 votes), and Edilberito B. Euraoba II (1,292 votes) for the 2016-2018 term of the vacant four seats of the Board of Directors. For the two vacant seats of the Audit Committee, Grace E. Caseres, (1,872 votes) and Paulino S. Sechico,(1,231 votes).

The cooperative's By-laws provides that only members

Siaton Satellite Office to Open Soon

DCCCO Multipurpose Cooperative will establish its 1st Satellite Office in Siaton, Negros Oriental, thus it is called DCCCO Multipurpose Cooperative Siaton Satellite Office. It is located at St. Nicholas de Bari Parish Compound, Poblacion 1, Siaton, Negros Oriental which is near the municipal hall and public park. The building is owned by the Diocese of Dumaguete. It will be an extension office of the Dumaguete Main Office which will serve the members in the area and the nearby towns/municipalities.

The establishment of a Satellite Office in Siaton, Negros Oriental, is in line with the Cooperative's 3-Year Strategic Direction and its 2016 Annual Operational Plan. It is the desire of DCCCO to bring its service closer to the members and communities and touch more lives, thus, the project aims to achieve the following objectives: 1) To provide members and the target community better access to affordable financial and other services; 2) To reach out to the unbanked sector and expand DCCCO's financial inclusion agenda to a larger sector of the populace; 3) To provide a more comfortable, fast and efficient service by decongesting the growing number of transacting members in the Main office; and 4) To maintain competitive advantage, ensure higher profitability and attain its goal of rural development through building a real mass-based, participative financial institution.

For membership recruitment and sustainability of the satellite operation, the Education Training and Information Committee (ETICom) of Dumaguete Main Office initiated a regular Pre-Membership Education Seminar (PMES) every Saturday from 9:00 a.m. to 12:00 nn at the Social Hall, St. Nicholas de Bari Parish Compound, Poblacion 1, Siaton, Negros Oriental.

The inauguration is scheduled on September 18, 2016.

Gender and Development (GAD) Activities Conducted and Participated

With the aim of enhancing awareness among DC-CCO Officers, Employees, Area Coordinators and members on Gender Issues in order to keep them vigilant not only of their rights but most importantly their responsibilities in the family and in the community they belong, the Gender and Development Committee had conducted seminars on Magna Carta of Women (RA 9710) and Violance Against Women and their Children (RA 9262) to the three big branches: 1) Bais Branch on April 30, 2016 with 32 in attendance, 2) Guihulngan Branch on June 25, 2016 with 32 in attendance, and 3) Bayawan Branch on June 29, 2015 with 37 in attendance. The Resource Speaker was Atty. Edric, Torremocha, Retained Lawyer of GWAVE. There was a lively discussion on the topics and majority of the participants saw the need that said topics be disseminated to a wider community and ensure the presence of both spouses for a better understanding on the gender issues.

Another concern being looked into by the GAD Committee is increasing the number of facilitators and ensuring that Gender and Development Program is being integrated in DCCCO operation. Hence, the Cooperative sent some of the Officers and Staff to the trainings and seminars sponsored by the Gender Equality Resource Center (GERC), Inc. Among these are Gender Sensitivity Training (GST) and Training of Trainers (TOT) on February 23-26, 2016 in Baguio City participated by the members of the Education,

Training and Information (ETI) Committee namely Charlemagne M. Calunsag, Salvador R. Sanchez, Sonia P. Garrucha and Jean Muñoz. Another is the Training on Mainstreaming Gender and Development (GAD) in Co-ops on July 11-14, 2016 participated by Dir. Edilberito B. Euraoba II (BOD member) Dr. Sylvia L. Flores (Vice-Chair GAD Committee), Dr. James Jed Rosales (Member, GAD Committee), Alma Tupas and Jayfrey Gapol (focal persons of Kabankalan and Siquijor Branches). The symposium aimed to awaken the participants' awareness of the different abuses to victims, legal actions to be taken and protection orders to be implemented. Atty.

Torremocha stressed that the Magna Carta does not promote superiority of women over men but it promotes equality.
