DCCCO'S Strategic Plan Vis-à-vis Ru Dir Edilberito B. Euraoba II, BOD Chairperson

On October 26, 2024, the Board of Directors and the Top Management conducted our Annual Operations Plan Evaluation to see what we have done in order to realize our recalibrated Blueprint for the years 2021 to 2025 referred to as the Strategic Plan of the Cooperative.

In that evaluation, we reviewed on the Strategic Objectives and our Strategy Map based on the Organizational Capacity, Internal Business Process, Financial Perspective, and finally, on the aspect of Member-Customer with the end view of uplifting the quality of life of the members and the community.

After a careful deliberation, we come into a conclusion that while we were able to increase our assets to a billionaire status and become successful in some areas like our products, programs, and activities for the members, and support programs to the community, we still fell short on the required standard on Institutional Capital (IC) and on Net Institutional Capital (NIC). IC refers to the Reserve Fund (RF) and Optional Fund (OF) while the NIC refers to the IC and Allowance for Probable Losses on Loans less the Portfolio at Risk (delinquent accounts).

The increasing delinquent accounts lead to increased provision for probable losses on loans which result to decreased undivided net surplus (UNS). Increasing delinquency is brought about by either delayed payments, insufficient payments, or non-payments of some members. The decreased UNS results to decreased amount for Reserve Fund and Optional Fund at the end of the year. In short, the delinquency problem has a major impact to our UNS.

Our Financial Team explained that if we are to attain Operational Safety and Soundness, we must build up our IC and NIC, and there is no other way to do it but to strengthen our collection methods and focus on quality loan releasing.

Today, we are once again called to do our part as member-owner-borrowers. As responsible borrowers, we need to pay our amortizations on time. If financial constraints come our way, we must inform the co-op immediately so that alternative courses of action can be offered by DCCCO. Our timely action then is crucial to our status as borrower and to the results of operation of our co-op.

As we prepare to craft the DCCCO Multipurpose Cooperative Strategic Plan for the next five years (2026-2030), let us be steadfast in our faith to God and remain to be vision-driven. In Proverbs 29:18, it says, "Where there is no vision, the people perish; but he that keepeth the law happy is he."

DCCCO reps attend ICA Conference, GA

On November 25-30, 2024, DCCCO delegates, in the persons of BOD Chairperson Edilberito B. Euraoba II, CEO Mildredo T. Umbac, and Kiddie Speaker Kendra Faith Ramirez Prestin, attended the International Cooperative Alliance (ICA) Global Conference (GC) and General Assembly (GA) in Bharat Mandapam, New Delhi, India. "Cooperatives Build Prosperity for All" was the theme for the event which was co-hosted by Indian Farmer Fertilizer Cooperative Ltd. (IFFCO) with the support of the wider cooperative movement in India.

The event was a historic one for three important reasons: 1) for the first time in the 130-year ICA history, the GC/GA was held in India, 2) it was also the official launch of the United Nations International Year of Cooperatives 2025, and 3) the Plenary Kiddie Speaker was coming from the Philippines – no other than from DCCCO Multipurpose Cooperative. Kendra Faith Ramirez Prestin, a 10-year-old elementary student and a member of DCCCO Youth Zone Laboratory Cooperative (DYZLC), commanded a standing ovation from the audience after she delivered her 15-minute speech and ably educated them the value of financial literacy among children and youth, the importance of the Aflatoun Program, and the role they play for the future of the cooperative movement.

The ICA-GC 2024 was a memorable event for it provided an opportunity to meet cooperative leaders from around the world, learn from new experiences and best practices, and explore opportunities to shape a cooperative future. The ICA-GC included thematic sessions with high-level speakers from within and outside the cooperative movement delving into different initiatives/programs, approaches, and concerns on Reaffirming the Cooperative Identity, Enabling Policy and Entrepreneurial Ecosystems, Nurturing Purposeful Leadership, and Building a Sustainable and Cooperative Future.

Supplemental to the thematic sessions were exhibitions, screenings of important films about cooperatives, activities promoting intergenerational solidarity as well as sectoral events, and events supported by the ICA-EU Financial Framework Partnership on Cooperatives in Development.

The delegates were also able to see and observe the beauty and vibrancy of India's history, culture and its robust cooperatives through co-op visits and other activities/programs.

Dumaguete City, Negros Oriental – On Tuesday, October 15, 2024, DCCCO Multipurpose Cooperative celebrated the blessing and inauguration of its newly relocated Locsin Satellite Office in Dumaguete City. The day's events began with a Thanksgiving Mass at 9 a.m., celebrated by Rev. Fr. FN Jun P. Vicoy, Director, Commission on Catechesis, Diocese of Dumaguete. Following the Mass, the Blessing and Inauguration Ceremony took place, highlighted by the ribbon-cutting led by Mr. Edilberto B. Euraoba II, Chairperson of the DCCCO Board of Directors. He was joined by Dr. Mildredo T. Umbac, Chief Executive Officer, and Hon. Felipe Antonio B. Remollo, Mayor of Dumaguete City. Rev. Fr. Vicoy also performed the blessing of the newly relocated office.

In her welcoming remarks, Ms. Marie Q. Pasco, Manager of the Dumaguete Branch, expressed the cooperative's excitement about the relocation, emphasizing the office's more central location and its potential to better serve the community. DCCCO conducts Aflatoun Teachers' Training on Child Social & Financial Education

To further enhance the implementation of the Aflatoun Program across the five identified partner schools of DCCCO, a comprehensive in-person Aflatoun Teachers' Training on Child Social and Financial Education was successfully conducted on October 19-20, 2024. The event took place at Crescencia C. Magbanua Hall, DCCCO Building, Sta. Rosa St., Poblacion 2, Dumaguete City, Negros Oriental.

DCCCO initiated the said training to achieve the following objectives:

- To define the Aflatoun concept of Child Social & Financial Education with emphasis on a child-centered approach to learning:
- To realize the value of social empowerment and financial literacy for teachers and students;
- To determine the effectiveness of the Teacher's Guide and find natural entries for curriculum integration;
- To inspire teachers in taking charge of their own financial lives;
- To bring learning, renewed commitment, and a fresh start for the schools, and evaluate the effectiveness of the savings process; and
- To provide knowledge of the nature of a cooperative and the products, services, and programs of DCCCO and DYZLC.

A total of 32 participants comprising the school heads, teachers, and faculty members from Colegio de Santa Catalina de Alejandria (COSCA), Hermenegilda F. Gloria Memorial Elementary School, Jantianon National High School, Ramon Teves Pastor Memorial Dumaguete Science High School, and Sumaliring High School actively engaged in the training sessions. They attentively engaged in the lectures, participated in the mock teaching demonstrations, and collaboratively developed action plans to enhance the program's implementation in their respective school.

This training was made possible through the invaluable support of the National Confederation of Cooperatives (NATCCO), the Department of Education Schools Division of Negros Oriental and of Dumaguete City, and COSCA. Their collaboration and commitment were instrumental in ensuring the success of this initiative.

DCCCO is very inspired to conduct more of these trainings in the years to come in order to bring the Aflatoun Program to children who dream for a better world and to the teachers who believe in child empowerment.



As part of the Co-op Month celebration, DCCCO offered free medical services through the conduct of Medical Mission and Bloodletting activity held on October 26, 2024 at the Crescencia Magbanua Hall, 4th floor, DCCCO Building, Dumaguete City. The free services included medical consultations with medicines and vitamins, eye checkup, blood typing, and fasting/random blood testing. The said activity ran from 8 a.m. until 3 p.m. and was open to all members and non-members, including senior citizens and children.

The target number of clients was achieved with more than 200 patients catered for their individual health need/s. There was a free visual acuity eye checkup which was facilitated by Eyesite Optical Clinic headed by Dr. Kevin Santiago. Free reading eyeglasses were given to patients who were diagnosed with presbyopia or the gradual loss of the eyes' ability to focus on nearby objects.

Blood typing was also offered to those patients who do not know their own blood type and a fasting blood sugar/random blood sugar test was readily available especially for elderly where high sugar or diabetes is common.

The bloodletting activity was equally successful. It was delightful to see a fair number of donors willing to donate blood.

In reality, every day there are patients needing unit/s of blood to survive. Per Red Cross, an estimate of 15 to 20 units a day are released from their office. Some days are even challenging because of out-of-stock units of blood and less available donors going to their office. Hence, the blood donations during the bloodletting activity will go a long way. In fact, a single blood donation can save up to three lives.

There were 32 successful blood donors. All of them received a 5-kilo bag of rice and snacks as simple token for their life-saving act.

The Medical Mission and the Bloodletting activity were a fine illustration of how being compassionate is – feeling or showing sympathy and concern for others.

Two esteemed leaders of DCCCO received recognition from the Holy Father, Pope Francis, in a solemn investiture and conferral rite at the St. Catherine of Alexandria Cathedral Parish on Dec. 11, 2024. Archbishop Charles Brown, apostolic nuncio to the Philippines, presided over the Mass and the investiture of the Dame of Saint Sylvester to former BOD Chairperson and now Vice-Chairperson Mary Magdalene Villegas, and the Knight of Pope St. Sylvester to long-time BOD Chairperson and currently BOD member William Ablong.

Brown said that "their conferral links them to the Holy Father in a very close way," noting that they take an oath of faithfulness and fidelity to the Holy See.

Bishop Julito Cortes of the Diocese of Dumaguete described the awardees as "close collaborators" of the local church in its various activities over the years.





Mary Magdalene Z. Villegas is a highly respected certified public accountant and former municipal accountant of the municipality of Sibulan. She has consistently demonstrated generosity and dedication in providing her expertise to design and implement effective accounting systems for numerous Diocesan offices and parishes. Her contributions extend to the Finance Board, Diocesan Schools, St. Joseph Seminary College, Our Mother of Perpetual Help Redemptorist Parish, St. Augustine of Hippo Parish, Sto. Rosario Parish in Cebu, Fr. Jacques de Boccard Foundation, Seminary Burse, and the Commission on Health. Despite her demanding schedule, she remains committed to serving the Lord as lector at the Carmelite Monastery, and actively supports the external affairs of the nuns there.

William E. Ablong has demonstrated unwavering dedication and service to the Diocese of Dumaguete, working closely with Bishop Julito Cortes, as well the late Archbishop Angel Lagdameo, and Archbishop John Du. He has long been the president of the Diocesan Council of the Laity, and a member of the Circle of Discernment. He also served as president of the Diocesan Organization of Renewal Movements & Communities for 12 years, and as a member of the Diocesan Electoral Board during the 2010, 2013, and 2016 elections. For 15 years now, he serves as president of the Parish Pastoral Council at St. Catherine of Alexandria Cathedral Parish. He established the Dumaguete Cathedral Parish Pre-Cana Team, and with his wife Yolly, they served as resource speakers for 14 years until 2022. He also developed and implemented Pre-Cana modules now used by other parishes.

As former Dumaguete Vice mayor, City administrator, and City agriculturist, he worked for a Christ-centered politics. He initiated daily morning prayers and First Friday masses at City Hall. He also created a Committee on Family Life, and passed several pro-poor and pro-environment City ordinances.

Dir. Ablong contributes regularly to the Dumaguete Metro Post and Bohol Times as a columnist, defending the interests of the Catholic Church. His passion for social media evangelization can be observed through his daily posts and video reflections of the gospel.

With this recognition, Dame Mary Magdalene Z. Villegas and Sir William E. Ablong continue to inspire others to serve the community with faith and commitment, embodying the Catholic Church's teachings in their work. Their achievements reflect DCCCO's enduring dedication to integrating Christian values in every aspect of service to the community.

The very highlight that moved everyone during the celebration was the statement of Asec. Luz H. National Confederation of Cooperatives (NATCCO) is the biggest federation of co-ops in the Philippines in terms of geographical reach, membership, financial capacity, and array of services. As of December 31, 2023, it now reaches 7,606,858 individual members coming from 957 co-ops and NGOs. It has 2,299 offices located all over the country with 207 employees. The consolidated assets of all its members amounted to P368 billion.

From May 16 to 18, 2024, DCCCO was honored to participate in the educational forum of the Philippine Federation of Credit Cooperatives (PFCCO) held at the Marco Plaza in Cebu City. This forum brought together cooperatives from across the country, offering a platform for knowledge sharing, collaboration, and collective growth.

As part of the program, Dr. Mildredo T. Umbac, CEO of DCCCO, served as one of the plenary resource speakers and delivered a compelling talk on "Cooperatives as an Engine of Community Development with Business Support." In his talk, Dr. Umbac emphasized the potential of cooperatives to act as a foundational support system for their members, especially those involved in business ventures. The presentation concluded with a brief yet impactful video documentation showcasing the Business Development Services (BDS) program of DCCCO, particularly on how it is being implemented across the three branches.

The response was overwhelmingly positive. Beyond raising awareness about the existence and impact of the BDS program, Dr. Umbac's talk inspired many cooperatives to consider implementing similar support systems for their members. The forum also allowed DCCCO to showcase the products of the members and share insights into the successful strategies and outcomes of the BDS program.

Significant Milestones for BDS

August 27, 2024 marked two major milestones for DCCCO's BDS initiatives.

Product Display Launch at DCCCO Hotel

The day began with a ceremonial contract signing at DCCCO HOTEL which officially opened its doors to BDS members. The agreement provided a dedicated product display space within the hotel premises, enabling members to reach a broader audience and boost their market exposure. Key participants in this initiative included Mr. Raymond Georpe of Lynsi Food Products, Spouses Alan and Liezl Corsame of Anzil's Fruit Wine Manufacturing, and Ms. Evelyn White of Lyn White's Cakes and Pastries. Each of these members showcased unique and exquisite products that highlighted the diversity and creativity within the cooperative.

BDS Benchmarking

Later that afternoon, the BDS team had the honor of being invited as key persons in the BDS Benchmarking Session hosted by PFCCO Southern Luzon Region League for the different cooperatives from Southern Luzon. The team presented updates on the BDS implementation in the three DCCCO Branches, highlighting both challenges and achievements.

DCCCO shared that for the 2nd and 3rd quarter of 2023, the program supported 64 entrepreneur members and 16 associations, with total loan releases amounting to P21.9 million and total savings deposits reaching P1.4 million. By the 1st and 2nd quarter of 2024, the program has expanded its reach, supporting 108 entrepreneur members and 16 associations, with total loan releases amounting to P21.3 million and total savings deposits reaching P1.4 million.

The session created a valuable platform for cooperatives from Southern Luzon to gain firsthand insights into DCCCO's BDS practices. The session encouraged a rich exchange of ideas and experiences, where the team shared best practices and engaged in area visits, allowing the visiting cooperatives to connect directly with some DCCCO members and witness their entrepreneurial journeys.

On the following day, the benchmarking initiative was concretized with area visits. The group departed Dumaguete City at around 6 a.m. and undertook a lengthy journey. Their first stop was at the Guihulngan Branch, where they connected with Ms. Ligaya Arculo and her team, who presented their native product line and how they were made. Next, they visited the residence of Ms. Mary Jane Reyes of Bais Branch located in Bulwang, Mabinay, who demonstrated the unique craft and health benefits of her turmeric tea. For the final stop, we arrived at around 7 p.m. back in Dumaguete City where we visited the residences of Mr. Raymond Georpe of Lynsi Food Products and Spouses Alan and Liezl Corsame of Anzil's Fruit Wine Manufacturing.

These visits not only enhanced product promotion but also resulted in positive sales and valuable feedback from the visiting cooperatives. Despite the long hours of travel, the visiting cooperatives deeply appreciated the opportunity to engage directly with their peers, gain exposure to different locally-made products, and receive firsthand insights into the impact of cooperative support on member businesses. The event highlighted the power of collaboration and mutual learning in driving cooperative success.

Community Development Program: A Comprehensive Support **Across Sectors**

DCCCO Multipurpose Cooperative has once again demonstrated its unwavering commitment to community development through a series of impactful projects and initiatives. Under its Community Development Program, the cooperative has allocated substantial resources to infrastructure development, environmental protection, peace and order, health and sanitation, community sponsorships, and community relief. These efforts are aimed at enhancing the quality of life for residents across multiple provinces and fostering sustainable growth and development.

Infrastructure Development

Significant investments have been made to improve educational and communal facilities. The construction of a school stage in Bais City West Elementary School at a cost of PHP245,000 and an administrative building for St. Andrews School, amounting to PHP1,800,000.00, are prime examples. Additionally, a new classroom for Malusay Elementary School was built for PHP1,700,000.00 and a dining ranch/feeding center at Dahile Elementary School was constructed at a cost of PHP400,000.00.

The cooperative also invested PHP500,000.00 in watershed development project at Maningcao, Sibulan, Negros Oriental, and PHP180,000.00 in the provision and installation of a drip irrigation system for the farm school at Cang-alwang National High School. Moreover, the renovation of comfort rooms, with a budget of PHP40,000.00 at Junob National High School, ensures better sanitation facilities. The cooperative also supported religious infrastructure with donations of PHP200,000.00 each for the construction of Pilving Marcy Parish and Kehalkalan Cethodral. construction of Divine Mercy Parish and Kabankalan Cathedral.

Environmental Protection and Conservation

The cooperative's commitment to environmental sustainability is reflected in its PHP1,419,000.00 allocation for tree growing, mangrove planting, and coral planting activities. These initiatives aim to enhance biodiversity and protect marine ecosystems. The deployment of eco-coral domes which serves as artificial corals for marine lives in Bais are also part of this program. Continuous monitoring and the employment of caretakers for these adopted sites ensure the longevity and effectiveness of these efforts.

Peace and Order

In support of peace and order, the cooperative has provided PHP150,000.00 worth of protective garments to barangay tanods/officials and traffic management officers across DCCCO branches. This initiative is aimed at ensuring the safety and security of community members and local law enforcement personnel.

Health and Sanitation

The health and well-being of the community are top priorities for DCCCO. The cooperative has allocated PHP1,903,000.00 in total for its supplemental feeding programs and medical missions across all branches. Additionally, the cooperative continues to support the feeding program activity of the Diocese of Dumaguete to address malnutrition and hunger among vulnerable populations.

Community Sponsorships

DCCCO continues to support the community through sponsorships and donations such as religious activities, school sponsorships, and donations for city and nationwide activities. These efforts ensure that schools have the necessary resources to provide quality education and foster a supportive learning environment.

Relief Assistance to the Community

The cooperative has also set aside amounts for relief assistance to the community, addressing immediate needs in times of crisis. Moreover, PHP776,000.00 was allocated to works of mercy, underscoring the cooperative's dedication to humanitarian efforts and support for the less fortunate.

Pagsapit ng Disyembre, karaniwan nang binibigyang-diin ang tradisyong pagpunta sa Simbahan upang kompletuhin ang siyam na Misa, na ayon sa paniniwala ng marami, ay magdudulot ng katuparan sa kanilang mga kahilingan kung makukumpleto ito.

Ngunit, ano nga ba ang Simbang Gabi at ano ang kasaysayan nito?

Nagsimula bilang relihiyosong tradisyon ng mga Pilipino ang "Simbang Gabi" o "Misa de Gallo" noong bandang 1660, sa mga unang taon ng Kristiyanismo sa Pilipinas. Ang mga misyonaryong prayle ang gumawa ng siyam na araw na Misa upang salubungin ang kapanganakan ni Kristo. Ang mga Misang ito ay ginaganap tuwing madaling araw, karaniwang bandang alas kwatro ng umaga, kung kailan ang mga tilaok ng manok ang nag-aanunsyo ng panibagong araw.

Ang salitang "gallo" ay mula sa salitang Espanyol na nangangahulugang tandang o manok. Kaya sa unang tilaok ng manok sa madaling araw, gigising ang buong pamilya at maglalakad (o sasakay ng balsa na hinihila ng kalabaw) patungo sa pinakamalapit na simbahan upang magsimba. Pagsapit ng ikalima ng umaga, pagkatapos ng Misa, ang mga kalalakihan ay tutungo na sa kanilang bukirin.

Ang desisyon ng mga prayle na gawin ang misa nang maaga ay sa kadahilanang karamihan sa mga Pilipino ay magsasaka at sila ay gumigising ng madaling araw upang magtrabaho sa bukirin. Gusto ng mga prayle na maitatak sa puso't isipan ng mga dating pagano ang kahulugan ng relihiyong Katoliko at maipagpatuloy ang pagpapalaganap ng Banal na Salita ng Diyos sa pamamagitan ng pagsama sa tradisyon ng mga Pilipino at ang pangangailangan sa pagsamba.

Sa ganitong paraan naging tradisyon ng mga Pilipino ang Simbang Gabi ("Simba" ay nangangahulugang Misa at "Gabi" ay nangangahulugang gabi o hapon) o Misa de Gallo. Isa itong relihiyosong tradisyon na ginagawa tuwing kapaskuhan na ipinasa mula magulang papunta sa anak at patuloy na isinasagawa ng mga Pilipino, mula noon hanggang ngayon.

Nang ito ay dinala ng mga Pilipinong imigrante sa Estados Unidos, ang tradisyong misa sa madaling araw ay nabago dahil hindi praktikal ang pagdiriwang tuwing madaling araw dulot ng malamig na panahon ng Disyembre, kaya naman ginaganap ito sa gabi sa mga lokal na parokya. Bagama't nagbago ang oras ng selebrasyon, nananatili pa rin ang diwa nito.

Dito sa Pilipinas, ang Simbang Gabi ay higit pa sa isang tradisyon—ito ay isang mahalagang bahagi ng pananampalataya at kultura ng mga Pilipino. Isa itong pagkakataon upang magkaisa ang bawat isa sa diwa ng panalangin, pasasalamat, at paghahanda para sa kapanganakan ni Hesus. THE BELFRY

The centuries-old watchtower-belfry of Dumaguete City in Negros Oriental is undergoing a significant restoration and site improvement project, moving forward as planned. The project, which kicked off in September, is about 11% complete and is set for full completion in the next

Msgr. Julius Perpetuo Heruela, the head of the Diocese of Dumaguete's Commission on Church Cultural Heritage, shared in an interview that the restoration is backed by a generous allocation of P9 million from the National Museum of the Philippines (NMP). This funding covers both the restoration of the belfry and the development of the surrounding site, ensuring that the cultural landmark is preserved for future generations.

Originally constructed in the early 1800s, the watchtower of the St. Catherine of Alexandria Parish was built to safeguard the church from marauding invaders. In 1867, two additional tiers were added, transforming the tower into a campanario, or bell tower, for the church. Thanks to its historical significance, the belfry is one of the oldest on Negros Island and was declared an Important Cultural Property by the NMP.

As part of the ongoing restoration, work is currently focused on the exterior of the tower. The NMP-Dumaguete team has been busy setting up scaffolding, restoring limestone slabs, clearing overgrown vegetation, and removing black deposits that have marred the structure's appearance.

Architect Glenn Enrique Balangkig emphasized that materials used for the restoration will closely match the original, ensuring the tower's authenticity.

The next phase of the project will see the removal of the attached public toilets and grotto, clearing the way for further structural restoration. However, some adjustments may be required due to nearby city-owned property, including a water tank, which could affect the site development

Looking ahead, Msgr. Heruela assured that the Diocese of Dumaguete and the city government are committed to the long-term maintenance of the belfry once the restoration is completed. The collaboration between these two entities will help ensure that this iconic heritage structure remains a symbol of Dumaguete's rich cultural history for generations to

A tangible link to the past
The restoration of the Dumaguete City Belfry is not merely an act of preserving brick and stone; it is a profound gesture of honoring history, culture, and identity. 
Its restoration is an acknowledgment of the invaluable lessons it imparts and a promise to future generations that the past, though frail and weathered by time, is worth preserving.

By restoring the Dumaguete Belfry, we ensure that its history continues to speak, its stories continue to be told, and its legacy endures.

Recognized by the National Museum of the Philippines as an Important Cultural Property, the belfry's preservation is a reminder of the enduring influence of Spanish colonialism on Philippine architecture and heritage. The tower is a testament to the architectural ingenuity of the past, and its continued preservation highlights the importance of safeguarding our diverse historical



In doing so, the restoration project contributes not only to local pride but to the country's broader cultural narrative, reinforcing the need to protect and cherish our shared heritage.

Beyond its historical and cultural importance, the restoration of the belfry has the power to inspire reflection. In a time when many of our cities and towns face rapid urbanization and modernization, the effort to restore and protect a historical site like the Dumaguete Belfry invites us to pause and reconsider what truly matters.

When the project is complete, the belfry will not only stand as a beacon of Dumaguete's rich heritage but will also serve as an enduring reminder that the past, though distant, has an enduring place in our present and future.

By breathing new life into this historic tower, we ensure that it will continue to watch over Dumaguete for generations to come, standing tall as a symbol of resilience, heritage, and the unbroken thread of time.


